## BRIGAMA-IBCC AT A GLANCE

*Assalamu'alaikum warahmatullahi wabarakatuh.*

The Gajah Mada Business Case Competition (GAMABCC) was first held in 2022, an initiative by the Faculty of Economics and Business Alumni Association of Universitas Gajah Mada (KAFEGAMA), in collaboration with PT Pupuk Kalimantan Timur (PKT) and FEB UGM. The goal from the start was to build one of Indonesia's most competitive and respected business case competitions — and to do so as a direct expression of the partnership between FEB UGM, KAFEGAMA, and the private sector in preparing the country's next generation of leaders.

The inaugural competition ran on the theme "Innovation and Sustainability in Agribusiness," and was designed to do more than test academic knowledge. It asked students to think critically, work under pressure, and develop ideas with real commercial and social implications. The ambition, then as now, is to produce graduates who are not only technically capable but ready to operate in a fast-moving business environment.

The 2026 edition marks a significant expansion. The final round will be held in Jakarta, in collaboration with Bank BRI. This partnership was initiated by Mr. Steven Yudiyanto, SEVP Human Capital at BRI and a Universitas Gajah Mada alumnus, brings the competition to its first international format under the BRI GAMA IBCC 2026 banner.

Participating in BCC offers students four things that classroom study alone rarely provides: deep exposure to business principles as they apply in practice; structured practice in critical thinking and creative problem-solving; direct experience translating theory into workable solutions; and the discipline of developing and presenting an original argument under competitive conditions.

This year's competition theme — "Empowering MSMEs: Innovative and Sustainable Business Solutions for Global Competitiveness" — reflects where the stakes actually are. MSMEs account for the majority of Indonesia's employment and economic output, yet they remain underserved in terms of access to capital, markets, and expertise. BRI's involvement in this competition is part of its longer-term work to change that.

## HANDBOOK

### BRI Gajah Mada International Business Case Competition

#### ABOUT THE COMPETITION

BRI Gajah Mada Business Case Competition is a manifestation of Gajah Mada University's (UGM) mission to prepare Indonesian leaders in the digital era. This competition is one of BRI and UGM's efforts to provide a platform for learning and mentoring by Indonesia's best business leaders.

Furthermore, the BRI GAMA IBCC 2026 was held to support the mission of the Faculty of Economics and Business UGM, especially in producing innovative and creative leaders to solve business problems in the current sustainable and digital era. To reaffirm its commitment to building a sustainable, adaptive, inclusive, and prosperous future, students participating in this competition will have the opportunity to gain real experience and make a real contribution to Indonesia's MSMEs through an internship with BRI, one of Indonesia's prestigious banks.

This competition is supported by KAFEGAMA (Gajah Mada Faculty of Economics Alumni Family) and Bank Rakyat Indonesia (BRI) as collaboration partners, as well as by all practitioners, academics, leading experts, and several media partners.

#### THEME

**“Empowering MSMEs Innovative and Sustainable Business Solution for Global Competitiveness”**

#### ACTIVITIES

1. BRI GAMA IBCC is an annual activity held in collaboration between BRI, KAFEGAMA, and FEB UGM.
2. This competition consists of three stages, namely the Preliminary stage (online, recorded presentation), BCC I (online synchronous presentation), and the Final Stage (offline).

#### OBJECTIVES

1. To inspire and engage Bachelor's (S1) and Master's (S2) students across International to develop innovative business solutions addressing real-world challenges and opportunities in the MSME sector, particularly in Indonesia.
2. To build a global network connecting students with professionals and MSME practitioners.
3. To promote sustainable business practices and support MSME development through adaptive and innovative solutions.
4. To strengthen BRI's International reputation as a leading financial institution committed to inclusive economic development and MSME empowerment.

## RULES

The following competition rules must be fulfilled by all participants in the BRI Gajah Mada International Business Case Competition (BRI GAMA IBCC) 2026. All teams are expected to understand and comply with the rules applied during the competition period. If a team violates the competition rules, that team will be disqualified from the competition.

1. **All participating teams must uphold the integrity of the competition.** Participants are required to uphold academic ethical standards throughout the competition, including refraining from plagiarism. Provisions regarding plagiarism will be regulated separately in this section.

2. **The cases used in this competition have never been published before.** Competition participants are prohibited from reproducing cases, either electronically and/or in print, or distributing cases to parties other than competition participants;

3. Each team member is registered as an active student at the university, proven by a cover letter or a letter of recommendation from the faculty or university.

4. Each undergraduate (S1) and post-graduate (S2) category team **must** consist of 3 students from the same university;

5. Each team must be supervised by a faculty member. The name of the faculty member, along with his/her NUPTK, shall be mentioned in the letter of recommendation.

6. Individuals who pass BCC II 2024 (Final) **are not permitted** to participate in BRI GAMA IBCC 2026; nevertheless, if they register in a different category, they are allowed to take part in BRI GAMA IBCC 2026. If the winner of BCC 2024 is participating in BRI GAMA IBCC 2026 in the same category, they will be disqualified by the committee.

7. Team members can be multidisciplinary from different faculties/majors within the university. At least 1 team member must be a student from the Faculty of Economics and Business. The composition of team members may not change throughout the competition.

8. When registering, participants need to prepare (soft copy):

a. Curriculum Vitae (CV) or Curriculum Vitae per member team;

b. Cover letter or letter of recommendation from the University (a template example is provided);

10. Team representatives are required to register via the link provided by the committee as follows <https://brigamaibcc.com/> ;

11. Each team must send a soft copy of CV, and a cover letter (free format, an example is provided with this handbook) via the link above;

12. Each participant is required to follow the Instagram/ Twitter/ Line/ Facebook FEB UGM, KAFEGAMA, and lifeatbri social media accounts;

13. All participants are required to take part in the entire series of events held throughout the competition;

### **THIRD PARTY PLAGIARISM AND INTELLECTUAL PROPERTY**

1. Plagiarism is defined as the act of intentionally copying or using written material and images created by another person without citing the source material, or including the writer's name and/or original publisher of the material.
2. Competition participants are allowed to search for materials and read research results or publications relevant to the cases used in the competition assignment, but the analysis must be carried out by themselves.
3. Participants are forbidden to copy the writing or analysis results from other parties from existing literature sources/databases/publications.
4. Provisions related to plagiarism apply to all outputs produced by participants, including reports/manuscripts, analysis results, videos, materials, and presentations.
5. Violation of this plagiarism provision will result in the team being automatically disqualified from the competition.

### **COMPETITION STRUCTURE AND TIMELINE COMPETITION CASES**

The cases given to the competition participating teams are case studies developed by the organizers and have never been published. Cases contain important and relevant information that can be used as a basis for analysis and argumentation by the participating team. Cases will be distributed to participants who are declared to have passed the administrative selection on the date set by the committee, as per the activity timeline.

### **ADMINISTRATIVE SELECTION STAGE**

Participants are required to register online via the link provided by the committee within the time limit specified in the timeline. Participants must complete the required documents at the time of registration (student ID, CV of all team members, and a cover letter from the University). The initial selection stage involves assessing the administrative completeness of the participating teams in accordance with the requirements. All team participants who pass the administrative selection are eligible to proceed to the next stages.

## **PRELIMINARY STAGE (PRE COMPETITION)**

All team participants who pass the administrative selection will receive a pre-competition business case (Business Case Challenge – BCC Pre Competition) and be given time to work on it in accordance with the criteria and requested outcomes. Participants are required to submit case analysis results before the specified deadline. The results of the case analysis are written in the form of a paper and a video presentation with the following format:

1. The paper and video presentation must be prepared in English.
2. The paper is prepared in .pdf format, with a maximum of 10 pages, including an executive summary but excluding appendices. The manuscript is typed using A4-size pages, Times New Roman font size 12, and spacing 1.15. The manuscript must be written using proper grammar and the correct academic paper format.
3. The video presentation should be no more than 10 minutes long and as creative as possible, while still complying with the Information and Electronic Transactions (ITE) Law. The judging panel reserves the right to deduct points if the video format does not meet the competition's requirements.

## **COMPETITION STAGE (BCC I AND BCC II)**

Based on the judging panel's assessment, the 20 best teams in each category will be selected to participate in the competition stage. At the first stage, teams will be given the first business cases (Business Cases Challenges – BCC I) to complete within a set deadline. Finalist teams must submit their case analysis results before the deadline.

The following are the provisions for preparing and implementing the BCC I stage.

1. BCC Phase I will be held in hybrid mode. Offline at MM UGM; Online (Zoom)
2. Participants must use English when preparing presentation materials.
3. The output that must be submitted is in PowerPoint format. Participants can prepare their presentation materials as engaging as possible while emphasizing the substance of the case analysis results. There is no limit on the number of slides in the presentation.
4. The presentation shall be delivered within a maximum of 10 minutes and as creatively as possible while still complying with the Electronic Information and Transactions (EIT) Law. The judging panel has the right to stop the team's presentation if they exceed the allowed time limit.
5. If technical problems occur in uploading data, participants are encouraged to report to the committee's WhatsApp number.

The assessment criteria for the substance of the case analysis presented in the competition stage (BCC I) include\*:

Based on the judging panel's evaluations, the 10 best teams in each category will be selected to participate in the final stage (BCC II). At this final stage, all teams will be given the second business case (Business Case Challenge – BCC II) to work on within a specific limited time. The team will present the case analysis results to the main judging panel, followed by a question-and-answer session. The following are the provisions for the final preparation and implementation stages.

1. The BCC II (Final) stage will be held offline at Menara BRILiaN.
2. The output that must be submitted in PowerPoint format. Participants can prepare their presentation materials as engaging as possible while emphasizing the substance of the case analysis results. There is no limit on the number of slides in the presentation.
3. The presentation before the judging panel has a maximum duration of 10 minutes, and is followed by a 10-minute question and answer session. The committee will provide a 5-minute break between teams to prepare their presentations. The judging panel has the right to stop the team's presentation if they exceed the allowed time limit.

The assessment criteria for the substance of the material presented in the final stage include\*:

## **JUDGING AND EVALUATION\***

### **EVALUATION**

1. In the preliminary round, the judging panel will evaluate each team based on:
  - a. Participants' understanding on given case;
  - b. The depth of the research results and analysis on the given case;
  - c. Clarity and logical flow in presenting case analysis results;
  - d. Applicability of the recommendations given;
  - e. Creative and innovative ideas offered in the given case;
  - f. Effectiveness of delivery/presentation of analysis results, as well as use of visual media;
  - g. Participants' ability to provide arguments in question answers;
  - h. The jury's assessment criteria refer to the previous section.
2. The judging panel is entitled to disqualify any participant that does not comply with the competition rules, for example, grammatical accuracy, the number of paper pages, video duration, or oral presentation duration;
3. The judging panel has the right to disqualify any participating team that violates academic integrity and plagiarism regulations.
4. The judging panel's decision is final and cannot be contested.

### **PRIVACY AND CONFIDENTIALITY**

Participants are prohibited from disclosing any confidential information related to the competition without the organizer's permission. The cases provided by the organizers in this competition, as well as the information from the organizing partners, are confidential.

### **USE OF PERSONAL INFORMATION**

Personal information provided by participants will be used by the organizer for purposes related to the competition. Personal information will also be shared with the judging panel and organizing partners for competition purposes. By registering for this competition, participants agree that:

1. The organizer has the right to record, take photos, or take screen captures of competition activities and upload them on the organizer's or partner's site and social media for publication purposes. Video materials, photos or screenshots may contain images, names, and/or voices of participants;
2. The organizer has the right to use participant information or data for competition purposes.
3. The organizer has the right to deliver participants' information or data to organizing partners for the purpose of building collaboration opportunities with participants.
4. Materials during the competition, including papers, videos, final round presentation materials, recordings, and photos, are the sole property of the organizer.
